Eastern Mediterranean University (EMU) Dr. Fazıl Küçük Faculty of Medicine academic staff member Assoc. Prof. Dr. Amber Eker participated as a speaker at the opening session of the 9th Neuroradiology School event held in the Turkish Republic of Northern Cyprus (TRNC) recently. The event started with a concert consisting of Cypriot melodies by EMU Education Faculty, Fine Arts Education Department academic staff member Erkan Dağlı and Pianist Atakan

Sarı. Participants who came to the TRNC from many different regions of Turkey had unforgettable moments at the musical performance.

Provides Doctors with Many Opportunities

In the opening session, EMU Dr. Fazıl Küçük Faculty of Medicine academic staff member Assoc. Prof. Dr. Amber Eker Bakkaloğlu delivered a speech titled "Artificial Intelligence Supported Applications in Neuroscience".

Assoc. Prof. Dr. Bakkaloğlu started her speech by stating that people, consciously or unconsciously, frequently use artificial intelligence-supported applications in their daily lives. Giving examples of artificial intelligence supported applications such as the voice search feature of phones, automatic face recognition in social networks, recognizing people's shopping preferences and offering them suggestions, or warnings about abnormal spending in banking transactions, Assoc. Prof. Dr. Bakkaloğlu stated that in recent years, applications supported by artificial intelligence have also found a place in the field of science and neuroscience with an increasing momentum. Assoc. Prof. Dr. Bakkaloğlu drew attention to the fact that in the field of health, these applications allow diagnosis, classification of diseases, and direction of treatment with great precision and speed. In the session, examples of the work of Dr. Fazıl Küçük Faculty of Medicine and EMU Engineering Faculty in this field were touched upon. Despite these applications, which are expected to be used much more in the future, the importance of the work of doctors in the field of Medicine, where human communication is at the forefront, was emphasized, and it was underlined that human labor is still superior to artificial intelligence in making new discoveries in the field of science.

FACULTY OF LAW ACADEMIC STAFF ATTENDED 1ST INTERNATIONAL PERSONAL DATA PROTECTION CONGRESS

Eastern Mediterranean University (EMU) Faculty of Law academic staff members Assoc. Prof. Dr. Demet Çelik Ulusoy and Assist. Prof. Dr. Can Azer presented a paper at the 1st International Congress on Protection of Personal Data, organized in cooperation with the Republic of Turkey Personal Data Protection Authority, Istanbul University Faculty of Law and Turkish-German University Faculty of Law. Organized between 12 and 14 November 2021 with the theme of "Developments in the World and Turkey", the congress was held face-to-face and online (hybrid). The congress aimed to create an environment that will increase the international competitive capacity of private and public sector actors in the data-based economy. Sessions were held in Turkish and English at the international congress. In addition to Hürol Mear, Head of the Personal Data Protection Board of the Turkish Republic of Northern Cyprus (TRNC), academics, public administrators and employees from Turkey and the world, relevant non-governmental organizations and participants interested in this field participated in the congress. The Congress was broadcast live on the YouTube channel of the Republic of Turkey Personal Data Protection Agency. For those who missed the presentations, recordings of the presentations are available on the relevant channel of the aforesaid Institution.

Three Presentations from EMU

Three different presentations were delivered from EMU among the papers that were evaluated

and accepted by the members of the Scientific Committee in accordance with the principles of blind refereeing. At the 10th Session held on the third day of the congress and chaired by Necmettin Erbakan University Faculty of Law academic staff member Prof. Dr. Nuran Koyuncu, EMU Law Faculty academic staff member and TRNC Personal Data Protection Board member Assoc. Prof. Dr. Demet Celik Ulusoy made a presentation entitled "The Right to Protection of Personal Data in the Turkish Republic of Northern Cyprus (TRNC) in the Context of the Applicability of the European Union General Data Protection Regulation (GDPR)". Afterwards, EMU Law Faculty academic staff member Assist. Prof. Dr. Can Azer presented a paper titled "The Conflict of Personal Data Protection and Right to Obtain Information in the TRNC in the Light of the Decisions of the TRNC Personal Data Protection Board and the Information Evaluation Board". Finally, in the same session, Assoc. Prof. Dr. Demet Çelik Ulusoy and Cyprus International University Faculty of Law Assist. Prof. Dr. Fatma Esenvel Hanaz's joint presentation titled "Tripartite View on Legal Compliance Conditions in the Processing of Personal Data: Turkish Republic of Northern Cyprus, Republic of Turkey and EU Review" was presented. English and Turkish abstracts of the presentations will appear in the International Proceedings Book to be published by the Republic of Turkey Personal Data Protection





EMU ORGANIZES INTERNATIONAL CONFERENCE ON SECURITY STUDIES IN COOPERATION WITH ADAM MICKIEWICZ UNIVERSITY

Eastern Mediterranean University (EMU) and Adam Mickiewicz University, Poland organized an international scientific conference within the scope of the collaboration agreement signed between the two institutions. The conference devoted to current challenges in international security was held online on 17 November 2021. Consisting of four discussion panels (global aspects of international security, European security, security issues in Central Eastern Europe and Eastern Mediterranean security), the conference aimed to encourage international cooperation, respect and dialogue culture.

"The Improvements Should be approached at Macro and Global Level"

Participated as one of the panel moderators, EMU Political Science and International Relations Department Head and the Chair of EMU Cyprus Policy Center (CPC) Prof. Dr. Ahmet Sözen delivered a speech during the Eastern Mediterranean security panel. Prof. Dr. Sözen started his speech by stating that in order to understand the Eastern Mediterranean, it is necessary to understand the developments at the macro and global level before the local and regional problems, and then focus on the region and the local. Stating that the populist policies have risen, more and more democratic countries have turned into an authoritarian regime, a new power structure has emerged in which the USA has weakened and China and Russia have risen relatively, problems between some European countries led by the USA and France within the NATO alliance, Prof. Dr. Sözen added that all these global developments had an impact on the developments in the Eastern Mediterranean region. Pointing out that Turkey, which is an important actor with the longest coastline in the region, takes these developments into account and therefore,



acts more assertively both diplomatically and militarily, Prof. Dr. Sözen emphasized that the underlying reason for the competition in the Eastern Mediterranean is not the possession and control of more natural resources, as many claim, but the change in power on a global scale.

"Trust Building between the Two Communities of Cyprus is Necessary"

EMU Political Science and International Relations Department academic staff member Dr. İpek Borman also delivered a speech during the Eastern Mediterranean panel and evaluated the limitations and potentials of the Eastern Mediterranean and Cyprus problem from a security perspective. Stating that she believes that the evaluation of the Eastern Mediterranean issue through the strategic prism of traditional security approaches is a problematic approach, Dr. Borman stated that this was seen in the security complex that emerged in the Eastern Mediterranean region. Dr. Borman emphasized that a security paradox has emerged in the region, which discourse and actions must be distrusted in order to overcome this, and that trust must be built between the two communities of Cyprus. She pointed out that eliminating social insecurity, trauma and fears in societies is of great importance for a more peaceful future, and that the Cyprus problem should be rethought by bringing the human factor to the fore.

FACULTY OF HEALTH SCIENCES, NURSING DEPARTMENT ORGANISES A TRADITIONAL ORIENTATION MEETING FOR NEWLY REGISTERED STUDENTS



Eastern Mediterranean University (EMU) Faculty of Health Sciences, Nursing Department held an orientation meeting on Thursday, 18 November 2021 between 13:30 and 15:30 for new students who registered to the Department of Nursing in the 2021-2022 Academic Year. In scope of the meeting,

held in two session groups with a consideration of the pandemic rules, a promotional video containing the activities of the department in the past years was screened. Following the opening addresses of Dean of the Faculty of Health Sciences Prof. Dr. Mehtap Malkoç and Head of Nursing Department Prof. Dr. Sevinç Taştan, faculty members and students were introduced to each other. EMU COMMUNITY INVOLVEMENT CENTER'S "25 NOVEMBER INTERNATIONAL DAY FOR THE ELIMINATION OF VIOLENCE AGAINST WOMEN" STATEMENT

Eastern Mediterranean University Community Involvement Center's Faculty of Education Representative and Chair of EMU Center of Women's Studies Assoc. Prof. Dr. Süheyla Üçişik Erbilen released a statement on the occasion of "25 November International Day for the Elimination of Violence Against Women". Assoc. Prof. Dr. Erbilen provided the following information in her statement titled "The Day Born from the Independence Struggle of Three Butterflies":

"Violence against women is the first and foremost a violation of human rights. It is observed in all areas of life, has a universal character regardless of social class, culture, nationality and race, and is rapidly increasing and becoming widespread,. Women and girls are exposed to all kinds of violence such as domestic violence, sexual harassment and abuse, rape, forced marriage and murders committed under the pretext of 'honour'. In order to draw attention to violence against women, which is experienced in every country of the world and seen as a public health problem, 25 November is observed as the "International Day of Elimination of Violence Against Women". The starting point of this day is the date when three sisters, Patria, Minerva and Maria Mirabal, who fought against the Trujillo dictatorship and were the pioneers of the Clandestina Movement, were killed in the Dominican Republic in 1960, but at the same time their struggle for independence became a symbol. The Mirabel sisters founded the Clandestine movement to oppose the dictatorship, and they became known as "butterflies" because one of them was codenamed "butterfly".

This struggle initiated by these three women became widespread within the country in a short time. The sisters were subjected to various oppression and torture because they were considered a threat to the government. Shortly after Trujillo's statement: "There are two threats in the country: the Church and the Mirabel Sisters", on 25 November, 1960, the three women were brutally murdered by torture. In 1999, the United Nations declared this day

as the "International Day for the Elimination of Violence Against Women" in order to raise awareness among individuals. In its most general definition, violence can be defined as the behavior that harms the physical or mental integrity of any living thing. The World Health Organization explains violence as "The intentional use of physical force or force against oneself, another person, a group or community in a threatening or actual manner that results in increased likelihood of resulting in physical harm, psychological harm, developmental problems or deprivation". In short, violence is all of the individual and collective actions that cause physical and mental harm to people through the applyication of force or pressure. From this point of view, it is observed that violence occurs in various forms.

- 1- Physical Violence: It is the first type of violence that comes to mind. It takes place with contact (pushing, hitting, etc.) or not (by breaking other objects around, giving you the message that I can do this to you, too).
- 2- Psychological Violence: It is not easy to be noticed. In other words, both the victim and the perpetrator may not realize that emotional violence is in question. The person perpetrating violence uses the victim's innate needs (such as being loved and feeling safe) in favor of his own interests
- 3-Sexual Violence: It is a form of violence that emerges with the thought that sexuality is an uncontrollable urge and the perpetrator tries to justify the results with various
- 4- Economic Violence: It occurs in the form of trying to prevent all economic opportunities that will make women stronger. It is practiced in different ways, such as preventing women from working in a paid job, interfering with working conditions, and confiscating their wages.
- So Digital Violence: It is a form of violence that has been increasingly observed in recent years. It is practiced through methods such as persistent monitoring, monitoring social media accounts, reading messages, and harassing them with different identities.

6-Dating Violence: It is a type of violence that is more common in the 15-25 age group, where peer pressure is high, and is more experienced in front of others.

7- Isolating: Although it is not a form of violence on its own, it is a very important form of thought and behavior that accompanies all forms of violence. It is perpetrator's damaging the victim's relations with all persons and institutions from which the victim can receive support. Not allowing her to meet with her family, relatives and friends is seen as keeping her away from mechanisms that can witness violence or complain.

Women are subject to violence just because they are women. The expectations and stereotypes of the society are the most basic elements that pave the way for violence. Therefore, the basis of eliminating violence is gender equality. Establishing gender equality, which means ensuring social, political and economic equality, is the only mechanism that will eliminate violence. In the preamble of the Council of Europe Convention on the Prevention and Combating of Violence Against Women and Domestic Violence (Istanbul Convention), which was adopted unanimously by the TRNC Assembly in 2011 and which deals with directly preventing violence against women, it is stated that violence against women is the violence that women suffer just because they are women it forces women to a secondary position against men, and it is gender-based violence.

In accordance with the Istanbul Convention, the states that signed the convention have four duties. These are the duties of policy making, prevention, protection-support and punishment-prosecution. Policy-making takes place with the state's policy-making to prevent violence against women; prevention takes place through practices that will change the perception of gender, especially education, in order to prevent violence against women, protection-support is realised by protecting and supporting the victims of violence against violence (such as providing shelter, providing legal and financial assistance) and



punishment-prosecution specifies what needs to be done regarding the prosecution of the perpetrator. As it is clearly stated in the Istanbul Convention, it is essential to follow a holistic approach in order to combat and eliminate violence against women and domestic violence. To this end, it is necessary to take the necessary legislative and other measures for the adoption and implementation of effective, comprehensive and coordinated policies across the state. In order to achieve this goal, it is important that all public institutions and organizations, non-governmental organizations, private sector, media, universities and all other relevant stakeholders act in cooperation. On the occasion of 25 November, the International Day for the Elimination of Violence Against Women, whilst reminding all those concerned of their responsibilities in this regard. we would like to express once again the longing for an equal world where women reach their rightful place in social, economic and political life away from violence on the basis of human rights."

DR. FAZIL KÜÇÜK FACULTY OF MEDICINE ACADEMIC STAFF MEMBER RELEASES A STATEMENT ON ANTIBIOTICS USE

Eastern Mediterranean University (EMU) Dr. Fazıl Küçük Faculty of Medicine and Marmara University Faculty of Medicine Department of Infectious Diseases and Clinical Microbiology academic staff member Assist. Prof. Dr. Buket Ertürk Şengel made a statement within the scope of World Antibiotic Use Awareness Week. Assist. Prof. Dr. Şengel's statement reads as follows:

"We Should Consume Antibiotics Consciously!"

"Antibiotics are drugs used to kill or stop the growth of disease-causing bacteria and are vital in serious infections. They can be effective against a single type of bacteria, or they can act against more than one type of bacteria. This situation has its advantages and disadvantages. Antibiotics produce some undesirable effects if used inappropriately.

There are some bacteria in the normal flora of the human body that are beneficial to us. One of the best examples of this is the bacteria called Lactobacillus found in the female vaginal flora, which protects the person from urogenital infections. Another example is the bacteria found in our intestinal flora that help break down and absorb indigestible nutrients and prevent the passage of toxins from the intestine to the blood. The antibiotics we want to give for a specific target cause the death of

these bacteria that we need, thus disrupting the protective mechanisms. For this reason, whether antibiotics are really necessary or not should be evaluated by a specialist, and if not, their consumption should be avoided.

Before starting the antibiotic treatment, it is necessary to evaluate whether the complaints are due to infection, and if it is due to infection, whether it is caused by bacteria. For example, not every patient who complains of burning while urinating has a urinary tract infection. Some reasons such as stones and anatomical disorders may also cause this complaint. If the present complaints suggest that the patient has an infection, it is necessary to evaluate whether the microorganism causing this is bacteria or not, at this stage. Antibiotics are for bacteria, there is no place for antibiotic treatment in many viral infections such as flu, hepatitis, or laryngitis. The body's immune system ensures that these infections limit themselves.

In general, the treatment of patients with suspected or proven bacterial infection can be started by taking necessary culture samples and anticipating the type of bacteria that may cause infection in that area. However, the patient's situation should be re-evaluated 48-72 hours later with the results and clinical condition, and antibiotic treatment appropriate for the bacteria whose name is now known should be

started or if it is not necessary, the treatment should be terminated. Wrong use of antibiotics (for example, when they are not needed, used for longer than necessary or in the wrong dose) causes serious problems such as drug-related undesirable side effects, antibiotic-associated diarrhea and especially the emergence of microorganisms resistant to antibiotics. The use of antibiotics must be evaluated on a patient basis. Different antibiotics can be given to different patients with the same infection, as the antibiotic that should be given varies according to the infection site. These drugs, which can have serious side effects, should be selected and dose adjusted considering the patient's heart, kidney, liver functions, and the presence of allergies. Another very serious issue is the problem of resistance. The development of resistance to an antibiotic means not being able to treat the infection caused by the bacteria on which that antibiotic is effective, which can sometimes be fatal. Bacteria that develop resistance can pass this resistance to other bacteria in the environment through genetic material transfer, and most bacteria in that environment will also have this resistance. And in such situations antibiotics cannot act against bacteria. Especially in hospitalized patients, it may have consequences leading to prolonged hospitalization and even death. This risk is higher, especially for patients with compromised immune systems. In addition, the




number of people affected may increase with the transmission of these resistant bacteria to other patients. It should be known that antibiotics used unconsciously in agriculture and animal husbandry may also cause this resistance.

The problem of resistance arising from the intense use of antibiotics necessitates the development of new antibiotics. However, this process cannot keep up with the resistance development rate. As a result of this situation, it is inevitable that the current antibiotics will be insufficient and the treatment of infections will become impossible."
